Pursuant to the advertisement dated 3.12.2018 for direct recruitment of four Peons and in terms of clause 4 of the aforesaid advertisement, it is notified that an Interview of 50 marks, as per the interview schedule indicated below, with the four benchmarks of Communication (10 marks), Work ethics (10 marks), Suitability (10 marks), reading ability (20 marks), shall be held in the premises of the office of Chief Judicial Magistrate of Morigaon, Assam to select the candidates for the aforementioned posts.

The applicants whose applications have been rejected may submit representation, in writing, if they so wish, to the undersigned, within a period of 10 days from today, during office hours.**

Calling of the candidates to the interview is purely provisional and does not necessarily mean acceptance of their candidature. The applications of the candidates are still under scrutiny and the selecting/appointing authority reserves the right to reject the candidature of any candidate at any stage on detection of any ineligibility condition. The candidature of the applicants shall be subject to fulfillment of all the criteria mentioned in the advertisement dated 3-12-2018. No T.A/D.A will be paid to the candidates for appearing in the Interview.

**Call letters for interview are being issued to the candidates by general post in the self addressed envelopes submitted by the candidates. If any candidate does not receive the call letter by 25.7.2019, the candidate may collect a duplicate call letter from the office of the Chief Judicial Magistrate, Morigaon during office hour on 26.7.2019. The selecting/appointing authority shall not be responsible for non receipt, late receipt etc. of call letters by the candidates due to postal delays etc. The candidates shall bring the Call Letters while appearing in the Interview.**
