**Terms and Conditions**

1. Candidates must be an Indian citizen as defined under Articles 5 to 8 of the Constitution of India.
2. Candidates must have registered their names in the Employment Exchange and shall mention their registration no. along with date in their applications.
3. Candidates must not be below 18 years or above 38 years of age as on 01-01-2018. The upper age is relaxable as per Government norms for SC/ST and persons with disabilities and ex-servicemen.
4. Candidates shall have to appear in a written-test and the candidates who qualify in the written-test will be called for viva-voce.
5. Candidates must furnish the following testimonials along with their applications:
  - a. Self-attested copies of certificates, mark-sheets in support of their educational qualifications, age, experiences, etc.
  - b. 3 (three) copies of recent pass-port size photographs with signatures on the back-side.
  - c. 1 (one) self-addressed envelope of 5 cm x 11 cm affixing postal stamp of Rs.5/-
  - d. Candidates shall mention their contact number at the bottom of the application form.
6. Candidates having knowledge of computer-applications and having requisite experience shall be given preference.
