ORDER

Dated Morigaon 8.12.2017

In terms of circular dated 6.1.2007 of the Hon'ble Gauhati High Court communicated vide Memo no.HC.VII-27/90/207-263/A dated 6.1.2007 and in supersession of all earlier orders and on consideration of pendency of cases, area of the police station and nature of the cases generated in the police station etc., the police station wise local jurisdiction of the Judicial Magistrates of Morigaon District is defined under section 14 of the Code Criminal Procedure, 1973 as follows:

It is provided that for recording of statement including confessional statement u/s 164 of the aforesaid Code, the Judicial Magistrate shall be nominated by the Chief Judicial Magistrate, Morigaon.

Subject to the aforesaid arrangement, the learned Judicial Magistrates may exercise all or any of the powers with which they are invested under the aforesaid Code.
This order will come into effect immediately.
